This Bill approves a settlement agreement between the City and the Office of Inspector General (OIG) of the United States Department of Health and Human Services. The City submitted a self-disclosure report to the OIG, explaining that, between December 1, 2022 and January 31, 2023, the City submitted invoices to Medicare, the Florida Medicaid program, Tricare, and the Veteran's Administration for ambulance transportation services that were provided by Paramedics and Emergency Medicine Technicians whose licenses had expired. This could have subjected the City to civil monetary penalties, assessments, and other sanctions. Consistent with the OIG's Self-Disclosure Protocol, the OIG and the City have agreed to settle this matter for a total settlement amount of \$167,111.31, which includes restitution and penalties. The overpayments made to the City totaled \$111,407.54. The City has already repaid \$12,456.52 and the remaining restitution due is \$98,951.02. This, together with a penalty of \$55,703.77, leaves a remaining balance of \$154,654.79 to be paid to the OIG.
